Description:

The aim of the course is to introduce students the interplay of new political and economic practices classified under the newly emerging literature of Geoeconomics specifically regarding its implications for the study of International Relations and International Political Economy. From a resurgence of state capital abroad, the weaponization of trade and investment policy through the introduction of investment screening mechanisms, economic sanctions and export controls, this course intends to discuss whether the World Order is moving from neoliberal globalization to geoeconomics. In the meantime, and more importantly, this course will introduce students to the intersection of economics and international relations, specifically identifying the links between the domestic political economy of states and its role in determining their preferences in international relations.

Broad Themes/Questions:

What is Geoeconomics? How is it different from Geopolitics? Is the new International Economic Order Geo-economic? Is Germany a geo-economic power? How and why not? What are Investment Screening Mechanisms (ISMs)? Energy, the Climate crisis and Geoeconomics

Assessment:

40% Presentation

Presentations should be 10 - 12 minutes long. The idea is to present the main argument of the text including a short summary and analysis. In the introductory session, I will go through the articles and spend some time explaining strategies to read and evaluate an article. The presentations should be based on the assigned papers. Based on the discussion in the first class, the idea is to put articles together as an answer to the question of the topic of the session in a conversation among the students.

60% Term paper

Term Papers should range between 3,500 and 5,000 words. More to be discussed on an individual basis during dedicated office hours, but generally, they should follow a proper format based on the CCCP guidelines. Students may choose their preferred citation style, but it should be consistent throughout the paper. We will dedicate a 90-minute session to an introduction to writing term papers with proper structure including an introduction, main arguments, and a conclusion. Office Hours for the Term Paper discussion will be announced later. The Deadline for the Term Paper is 15th August 2023 (open to discussion). Please send them at ig@mpifg.de
